## 2026 FEBRUARY GIVEAWAY. ONLINE PURCHASE SWEEPSTAKES. OFFICIAL RULES

NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID OUTSIDE FABICK CAT SERVICE TERRITORY AND WHERE PROHIBITED.

**1. Sponsor:** John Fabick Tractor Company (dba Fabick Cat), 1 Fabick Drive, Fenton, MO 63026.

**2. Eligibility:** Sweepstakes is open only to legal residents of the United States who, at the time of entry, are eighteen (18) years of age or older and are located within the Fabick Cat Service Territory. Employees, officers, directors, and representatives of Fabick Cat, its affiliates, subsidiaries, advertising and promotion agencies, and immediate family members or persons living in the same household are not eligible. Void outside the Service Territory and where prohibited by law. In order to enter the Sweepstakes or receive a prize, you must fully comply with these Official Rules and, by entering, you represent and warrant that you agree to be bound by these Official Rules and the decisions of the Sponsor, whose decisions shall be binding and final in all respects relating to this Sweepstakes.

**3. Sweepstakes Period:** Sweepstakes begins on February 1, 2026 at 12:00 a.m. Central Time ("CT") and ends on February 28, 2026 at 11:59 p.m. CT ("Promotion Period"). Sponsor's computer is the official timekeeping device.

### 4. How to Enter:

- a. **Online Transaction Entry:** Eligible individuals who complete a qualifying online transaction with Fabick Cat during the Promotion Period will automatically receive one (1) entry.
- b. **Alternate Method of Entry (AMOE):** To enter without making a purchase, hand-print your name, address (must be within the Service Territory), phone number, email, and date of birth on a 3"x5" card and mail it in a stamped envelope to: Fabick Cat Sweepstakes Entry, 1 Fabick Drive, Fenton, MO 63026. Mail-in entries must be postmarked by February 28, 2026 and received by March 13, 2026. Each mail-in entry counts as one (1) entry.
- c. Limit one (1) entry per person regardless of method.

**5. Winner Selection:** On or about March 13, 2026, Sponsor will conduct a random drawing from among all eligible entries received. Odds of winning depend on the number of eligible entries. Potential winners are subject to eligibility verification by Sponsor and shall provide Sponsor with all information reasonably requested by Sponsor to verify eligibility.

**6. Prize:** One (1) prize package will be awarded: consisting of the following items: a Cat Dartboard, (2) Cat Barstools, 2 Cat Glassware Sets, and a CAT LED Neon Sign (Approximate Retail Value: \$712). If potential winner is unreachable after Sponsor has exerted reasonable effort to contact the winner, ineligible, declines, fails to respond, or otherwise is found to have not been in compliance with these Official Rules prize may be forfeited and awarded to an alternate.

**8. Publicity Release:** Except where prohibited, participation constitutes winner's consent for Sponsor to use winner's name, likeness, and prize details for all purposes without compensation, including, but not limited to, advertising, trade and/or promotion on behalf of Sponsor, in any and all forms of media, now known or hereafter devised, including, but not limited to, print, TV, radio, electronic, cable, or World Wide Web, without further limitation, restriction, compensation, notice, review, or approval.
